WHEREAS in terms of Section 15 (1) of the NCTE Act, 1993 S.R.M. - NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to S.R.M. College of Education, V.P.O.- Talwandi RANA, Hisar-125001, Haryana, for conducting D.Ed. Course of two year duration with an additional intake of 50 (Fifty Only) students thereby making the total annual intake of the institution to 100 (One hundred only) (Two unit) under clause 7(12) of Regulation dated 13-1-2006 subject to fulfillment of the following:
 - The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Northern Regional Committee.
 - The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.
